### LETTER FROM THE PRINCIPAL OFFICER

#### Revision of contributions effective from 1 July 2026

The Board of Trustees, in conjunction with the Scheme's actuaries and Scheme Management, finalised the contribution increases for the Scheme with effect from 1 July 2026. We are pleased to inform you that the contributions for both the Imperial Motus Med Health and Budget Plans will be increased by an average of **6.9%** with effect from **1 July 2026**.

In addition, the income categories according to which your contributions are calculated will be increased by **4.5%** for both the Imperial Motus Med Health and Budget Plans with effect from 1 July 2025. This should prevent the possibility of members being pushed into higher income categories due to annual salary increases. Scheme Management assures members that Imperial Motus Med continues to offer better value for money compared to similar schemes in the industry.

Imperial Motus Med submitted the proposed contribution increase for 2026 to the Council for Medical Schemes in March 2026, and these increases are **subject to the approval** from the Registrar.
